

## First Quarter 2016 Review and Outlook

### Another Ride Around the Globe

Broad macro concerns resurfaced with a vengeance at the start of 2016 with a January sell off that ripped across the globe. Worries about rising US interest rates, slowing growth in China's economy, a strong US dollar and weak oil prices were the main culprits. By mid-February, the S&P 500 was down 10% year to date. As oil prices began to stabilize, and the expectations for higher US interest rates diminished, markets calmed down and equity prices reversed their downward ride. The volatility was dramatic with the S&P 500 ending the quarter in the black. The technology laden NASDAQ remained negative. Fortaleza's growth strategies were challenged primarily due to their overweight in technology.

**Portfolio Positioning**

Our overweights are in Consumer Discretionary and Technology. We believe that the stronger employment environment and lower gas prices will support an increase in consumer spending overall. In technology, while we still believe in the strong revenue growth prospects, we did trim positions and booked profits both in the fourth and first quarters particularly in the large social media stocks. Our most notable underweight has been in Consumer Staples, although we are moving closer to a neutral given the current market environment. Energy has also been an underweight for some time given the oversupply of oil. We also have an underweight in healthcare which we believe is prudent given the market environment and the possible return of anti-biotech's pricing rhetoric coming from Washington as the political election campaigns intensify.

## **Market Outlook**

We remain bullish on the U.S. equity markets for the long term, but as was the case at the start of the fourth quarter, we have been cautious short term. We have already experienced a great deal of volatility so far in 2016 and we believe that it will continue for a while longer. In the very near term, many stocks rallied back in March and may be overbought. Ultimately earnings reports/guidance will play a key role in the direction of the markets and reports for the first quarter have begun. Early reports have been mixed: Alcoa disappointed while JP Morgan beat expectations. China will continue to be a major focus as will the outcome from the upcoming UK (European Union Memberships) decision in June. Investors will also be watching how the upcoming US Presidential election campaign unfolds. We truly believe in the strength of the U.S. consumer given the better employment environment and the lower gas prices we are all benefiting from. As previously stated, we are overweighted Consumer Discretionary. We are also overweighted Technology where we continue to see strong growth.
