Third Quarter 2015 Review and Outlook

Investment performance around the globe was awful. The S&P 500 ended the quarter down close to 7%, while major indices in Europe were down around 8% and China's mainland markets down close to 30%. Weak economic growth in emerging markets (particularly China), continued weakness in commodity prices and the resulting negative implications for Glencore and Petrobras along with the surprise devaluation of the Chinese Yuan, combined to unravel investors and culminated with an official correction on August 24th. Hillary Clinton's drug price tweet toward the end of the quarter triggered a selloff in biotechs. Additionally, the appearance of indecision from the Fed disappointed investors as they chose not to increase rates at their September meeting. On the geopolitical front, we saw Putin asserting himself into the Syrian conflict and here in the U.S., Boehner's resignation sparked fears of more dysfunction in Washington. All in all, the quarter delivered the first correction in nearly four years.

Fortaleza's small cap portfolios, while down double digits, fared better than the benchmark with the help of several sectors, most notably, consumer discretionary, industrials, materials, financials and healthcare. On average, we underweighted these sectors which also helped in producing a positive alpha. Our large cap portfolios benefited from a stronger consumer discretionary sector as well but gave back some of the gains from the prior quarter mainly due to the selloff in biotech's that occurred toward the end of the quarter.

Portfolio Positioning

We believe healthcare and technology offer the best upside potential as the companies in these sectors should benefit from strong revenue growth and generally stable to improving margins. Consumer Discretionary should also perform well from a brighter employment environment and a slight pickup in wages. Financials are mostly a play on interest rates and should benefit once the Fed makes its move away from zero. We are not as positive on energy stocks because of the current oversupply and the potential supply from Iran hitting the markets. We believe the current rally in energy stocks may be temporary. Lastly, we are somewhat neutral on Industrials and Materials due to continued headwinds from a strong dollar.

Market Outlook

We remain bullish on equity markets for the long term but a bit cautious near term. The peak of earnings reporting season has begun. We believe that results will be very mixed which may cause investors to pause before putting money to work. For example, Nike reported very strong results out of China and Apple has hinted that demand for their phones in China has been strong. On the other hand, companies like Yum Brands (Taco Bell and Kentucky Fried Chicken) have experienced weakness. We also believe that uncertainty around the Fed's decision to raise interest rates along with the Boehner/McCarthy surprises all add to the proverbial wall of worries. Additionally, geopolitical events in the Middle East and Russia's increased involvement in Syria do not help.

Why then are we bullish longer term? We see a stronger consumer as a result of an increase in real incomes (from lower commodity prices). Additionally, there is already evidence of a much needed increase in household formation which should bode well for construction/housing. Even if the Fed increases rates, the increase will be modest and future increases very gradual which should not deter home buying. We do need an increase in business spending and we believe that it will materialize. The U.S. economy is unlikely to enter recession anytime soon which should give stocks a much needed boost as we move into the New Year.
