Simply looking at the company's projected revenue and adjusted EBITDA, compared to Bloomberg complied consensus, they're 6%/11% higher on revenue for FY24/FY25, respectively, and 16%/24% higher on EBITDA. This is consistent with the view that Abcam's investment phase is almost ending.</p> <p>When we asked the same question with Alan about timing, his response was 1) valuation is at a more reasonable place for the buyer/seller to agree; 2) the significant risks associated with executing Dr. Milner's plan. I think that point is also fair - the alternative (assuming the shareholder vote returns NO would possibly lead to Milner replacing the current team) has a wider downside with limited upside.
