OakBrook Select Equity Strategy Second Quarter, 2016 Report

From inception (May 2, 2016), through the end of the second quarter, the Select Equity Strategy returned 1.11% before fees, out performing the 0.67% return of the Russell 1000 Growth Index.

During May, stocks registered gains in see-saw trading with the strongest rallies led by Energy and Technology shares. Concerns about foreign economies defined the first week of the month, with reports of weaker than expected factory activity in China and the UK triggering a global stock market sell off on May 3. By the May 5 close, the Russell 1000 Growth Index was down 0.66% for the month to date. On May 10, Energy shares led a 1.22% Russell 1000 Growth Index rally after crude oil prices rose more than 3%. However, the US stock market gave up most of these gains on May 11 as disappointing earnings from **Disney** and **Macy's** weighed on equity prices. By the May 13 close, the Russell 1000 Growth Index was once again down more 0.5% for the month to date. On May 16, Energy shares led a 1.04% Russell 1000 Growth Index rally after crude oil prices rose more than 4%. Once again, the US stock market could not sustain its gains as Federal Reserve Bank Presidents Lockhart and Williams both indicated that at least two hikes in the Fed Funds rate might be warranted in 2016. By the close on May 19, the Russell 1000 Growth Index was down 1.12% for the month to date. On May 20, Technology shares led a 0.68% Russell 1000 Growth rally after Applied Materials issued a better than expected sales forecast. Technology shares continued to lead the way as the Russell 1000 Growth gained more than 1.5% on May 24. On May 25, Energy shares led the Russell 1000 Growth advance of 0.51% as crude oil prices rose more than 2%, nearing \$50 per barrel. On May 27, the Financial sector led the US market higher and the Russell 1000 Growth Index to a gain of 0.48% after Federal Reserve Chair Yellen indicated that an increase in the Fed Funds rate would be appropriate in coming months. The Russell 1000 Growth Index returned 1.94% for the month overall. Select Equity trailed the Index due to Select's general emphasis on stocks with stable returns as well as weak performance from individual holdings such as Caterpillar, Nike, Schlumberger, and **Disney**.

During June, the US stock market rose and fell with shifting investor sentiment but ultimately finished the month very close to where it started. The month began with investors optimistic about prospects for economic growth. A steady global rally in equity and commodity prices pushed the Russell 1000 Growth Index to a gain of more than 1% by the close on June 8th. Sentiment turned more bearish on June 9, as investors began to focus on the upcoming UK Brexit referendum to decide whether or not Britain should exit the European Union (EU). By the June 15 close, the Russell 1000 Growth Index was down more than 1% for the month to date. In the wake of the June 16 murder of UK lawmaker Jo Cox by a Brexit supporter, UK polls shifted in favor of Britain remaining in the EU. Investors responded enthusiastically to the shift, pushing the Russell 1000 Growth Index to a gain of 0.31% for the month to date by the June 23 close. On June 24, investors woke to the surprising news that the Brexit referendum had passed. Uncertainty



regarding precisely when and on what terms Britain would exit the EU triggered sharp declines in equity and commodity prices around the world. By the close on June 27, the Russell 1000 Growth Index had declined more than 5% from its June 23 level. On June 28, stocks began to rally back on optimism that political leaders were committed to minimizing the fallout from Britain's eventual exit from the EU, along with the realization that the exit was likely to be more than two years in the future. Ending the month with a three day rally, the Index was able to recover the vast majority of its June 24 and June 27 losses. The Russell 1000 Growth Index returned -0.39% for the month overall. Select Equity outperformed, benefiting from good stock selection as well as investors' general preference for the strength and stability of Market Power companies in a volatile stock market environment.

Near the end of the quarter, OakBrook reduced its position in **Agilent** and used the sale proceeds and some cash to initiate a new position in **Varian Medical Systems**. The decision to reduce the Agilent position was based on its rich valuation. Varian Medical Systems is the global leader in production of radiation therapy systems and X-ray diagnostic imaging systems. Sales of its radiation therapy systems have been strong and are likely to remain so for at least the next decade due to the efficacy and cost efficiency of radiation therapy as a treatment for several types of cancer. However, recent sales of its X-ray imaging systems have disappointed, depressing Varian's stock price to an attractive entry point. The recently announced plan to spin off the X-ray imaging business will sharpen Varian's focus on its Market Power position in radiation therapy, further enhancing the attractiveness of the stock.

Looking ahead, we expect the US economy will be able to overcome the drag of a weak global economy and continue to grow at a modest pace. Recognizing the challenging global environment, the US Federal Reserve has further reduced the number of expected 2016 increases in the Fed Funds rate from two to at most one. US stock market returns are likely to remain volatile given continued uncertainty about China, crude oil prices, and Britain's exit from the European Union. The US presidential election also has the potential to move markets. We expect Select Equity's emphasis on large cap stable stocks will provide a performance advantage in this environment.
